VAT Registration & Returns

All businesses with a taxable turnover of more than £90,000 are required to register for VAT and pay HMRC at the end of each financial quarter. HMRC introduced their Making Tax Digital which came into effect on April 1st 2019 and requires businesses to submit VAT returns online unless your business is not required to register but has opted in voluntarily.

We manage all aspects of VAT registration, from reconciling your sales and purchases over each accounting period to the preparation and submission of returns in timely fashion to avoid penalties. This takes the burden of additional paperwork away, leaving you free to run your business.

Corporate Audit

This is a review of a company's financial statements and internal controls by an authorised third party firm or the company's own internal audit team, if one exists. The process is essential to ensure the accuracy of financial records, potential areas of risk and to maintain regulatory compliance. This process is independent of day-to-day accounting and is unnecessary if you qualify as a small business*.
